Jeffrey M Wooldridge is a Distinguished Professor of Economics and Walter Adams Distinguished Faculty Fellow in Economics at Michigan State University, where he has taught since 1991. He previously taught at MIT. He received his Bachelor of Arts, with Majors in Computer Science and Economics, from the University of California, Berkeley, and his Doctorate in Economics from the University of California, San Diego. Dr Wooldridge is a Fellow of the Econometric Society and of the *Journal of Econometrics*, and a founding fellow of the International Association for Applied Econometrics. His other awards include the Distinguished Author Award from the *Journal of Applied Econometrics*, the Plura Scripset Award from *Econometric Theory*, and the Sir Richard Stone Prize from the *Journal of Applied Econometrics*. He has also served on several editorial boards, including as Editor of the *Journal of Business and Economic Statistics*. Dr Wooldridge has written chapters for the *Handbook of Econometrics* and the *Handbook of Applied Econometrics*. He is the author of *Introductory Econometrics: A Modern Approach* (South-Western, 7e, 2019) and *Econometric Analysis of Cross Section and Panel Data* (MIT Press, 2e, 2010).

Bart Lambrecht is a Professor of Finance the Cambridge Judge Business School and Director of the Cambridge Endowment for Research in Finance (CERF). Previously he taught at Lancaster University and he has held visiting positions at the University of Calgary, UCLA and the MIT Sloan of Management. He received a BA in Applied Economics from the University of Antwerp and an MPhil in Finance and a PhD in Economics from the University of Cambridge. Dr Lambrecht is a Fellow of the CEPR. He is a former editor-in-chief of the *Journal of Corporate Finance* and a former Associate Editor of *Financial Management*, and the *Review of Finance*. He is currently an associate editor of the *Journal of Banking and Finance* and a member of the editorial board of the *Journal of Business Finance and Accounting*. He is the Founder and Lead Organizer of the annual Cambridge Corporate Finance Theory Symposium.

Professor Lambrecht has published papers on a variety of topics in corporate finance. His earliest work studies the role of strategic behaviour and competition for the valuation and exercise of real options. Related work examines the role of product market competition and human capital for corporate capital structure. Some of his papers study the timing and dynamics of corporate restructurings (such as takeovers, mergers, outsourcing decisions, corporate bankruptcies, and bank insolvency resolution mechanisms), and explore how these restructurings are influenced by agency or strategic considerations. Professor Lambrecht also developed two theories that generate the celebrated Lintner (1956) dividend model. One theory argues that Lintner-style payout smoothing results from managerial risk aversion and habit formation, whereas another theory shows that this type of payout and income smoothing can also result from asymmetric information and learning between inside and outside shareholders. His most recent work focusses on the dynamics of financial policies and group decisions in private firms and partnerships. His research has been published in leading academic journals, including the *Journal of Finance*, *Journal of Financial and Quantitative Analysis*, *Journal of Financial Economics*, *Review of Finance*, and the *Review of Financial Studies*.

Chandrasekhar Krishnamurti is currently a Professor of Finance at the University of South Australia Business School. He has held academic roles at Monash University, National University of Singapore, Nanyang Technological University, Auckland University of Technology and Indian Institute of Science. His research expertise spans the areas of corporate governance, corporate social responsibility, market microstructure and green finance.

He has published over 75 papers in journals such as the *Journal of Corporate Finance*, *Journal of Banking and Finance*, *Journal of Business Research*, *Australian Journal of Management*, *Corporate Governance: An International Review*, *Financial Management* and *Journal of Financial Research*.

He has conducted externally funded industry-oriented research for organisations such as the Global Risk Institute in Financial Services, Toronto, Financial Planning Association, Centrepoint Alliance and Magellan, Melbourne Centre for Financial Studies, and United States Agency for International Development.



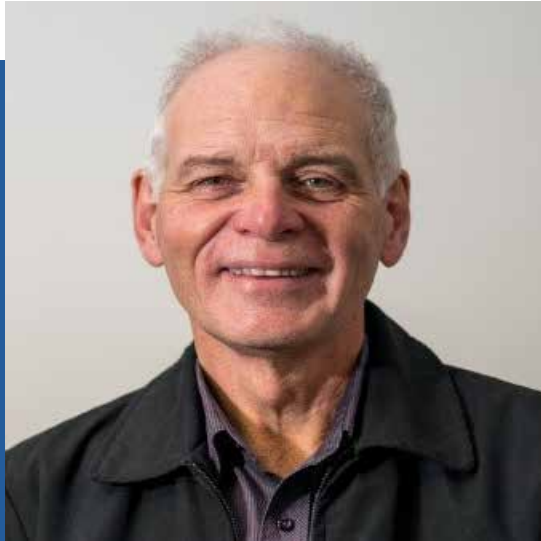

Professor Malenko's research has appeared in top academic journals and has received several awards, including the Brattle Prize for a distinguished paper in corporate finance in the *Journal of Finance*. She is an Associate Editor at the *Journal of Finance*, *Journal of Financial Economics*, and *Journal of Financial and Quantitative Analysis*, and she serves on the board of directors of the American Finance Association, Western Finance Association, European Finance Association, and Financial Management Association.

Robert Faff, FASSA, is a Professorial Fellow at Bond University and an Emeritus Professor at UQ. He is currently Vice-President of EIASM and BARDSNet Chair. He has an international reputation in empirical finance research: securing 15 Australian Research Council grants (funding exceeding \$4 million); 350+ refereed journal publications – 46 x A* (ABDC); career citations 19,000+ (Google Scholar); with a h-index of 71. His particular passion is nurturing the career trajectories of early career researchers. Robert has supervised almost 50 PhD students to successful completion and examined more than 50 PhD dissertations. Building on a 40-year academic career, his signature focus is [“Pitching Research”](#) with worldwide penetration signalled by: (a) 22,700+ SSRN downloads; (b) 400+ pitching talks/events; (c) at 37 Australian universities; and (d) spanning 54 different countries. Further, he is the Founder and President of the InSPiR2eS research network <https://pitchingresearch.com/inspir2es-network/>, a globally-facing research network primarily aimed at research training and capacity building, resting on a foundation theme of responsible science. In addition, Robert is Editor-in-Chief of *Pacific-Basin Finance Journal*; formerly: Editor of *Accounting and Finance* (2002-2011) and Associate Editor of several other leading journals including *Abacus* and *Australian Journal of Management*.

Julian Franks is a Professor of Finance at the London Business School, and former Academic Director of the London Business School's Centre for Corporate Governance. An expert in corporate finance, his research focusses on bankruptcy and financial distress, corporate ownership and control, shareholder activism by both hedge funds and active asset managers, cost of capital and regulation. His work on ownership and control (with Colin Mayer and Stefano Ross) has won two international prizes. Two of his other papers have won Best Paper Awards by the *Journal of Financial Intermediation*. He has been an editor of the *Journal of Law, Finance and Accounting*, and an Associate Editor of various other finance journals. He has served as a member of the DTI-Treasury committee reviewing the United Kingdom's insolvency code, as a member of the Company Law Review's Committees on Corporate Governance, and as a member of the Breedon Committee on Non-Bank Sources of Finance. He has also been Visiting Professor at the University of California at both Berkeley and Los Angeles, and at the University of North Carolina at Chapel Hill.

Julian has been an Advisor to the Competition Market Authority, the Water Industry Commission for Scotland, a past member of the Advisory Board of ORR (the regulator for Network Rail), and was a member of an appeals panel for the New Zealand Commerce Commission. He has advised (with Professor Brealey) the Office of Constitutional Affairs on the issue of outside equity for law firms, and provided advice to a Treasury Committee chaired by Paul Myners on a review of the governance of mutuals. He was an Adviser to Ofcom for more than 15 years, and acted as an expert for them in three appeals to the Competition Authority. Julian is a Partner at the consulting firm OXERA.

Nandini Gupta is an Associate Professor of Finance and Boquist-Meyer Faculty Fellow at the Kelley School of Business at Indiana University. She is also a Senior Research Fellow at the Deepak and Neera Raj Center on Indian Economic Policies, SIPA, Columbia University. Gupta serves as an Associate Editor at the *Review of Finance*, Associate Editor at the *Journal of Banking and Finance*, and Editor, *International Review of Finance*. Her research focusses on the political economy of finance, financial development, labour, and emerging markets. Her research lies at the intersection of empirical corporate and international finance, with a focus on the areas of financial development, political economy, and labor and finance. She has published papers in leading Finance and Economics journals including *Journal of Finance*, *Journal of Financial Economics*, *Review of Financial Studies*, *Journal of Financial and Quantitative Analysis*, *Rand Journal of Economics*, and *European Economic Review*, and has written several book chapters. Gupta's papers have been cited over 2000 times in academic journals and PhD dissertations. Additionally, her work has informed governments and international policy organisations.

Andrew Ellul is a Professor of Finance and Fred T Greene Chair of Finance at the Indiana University's Kelley School of Business. He is the Executive Editor of the *Review of Corporate Finance Studies*, and was formerly Editor of the *Review of Finance*. He joined Indiana University after completing his PhD at the London School of Economics and Political Science. His research interests focus on empirical corporate finance, labour and finance, institutional investors' trading and risk management, and market microstructure. Andrew is a Research Associate of the Centre for Economic Policy Research, Center for Studies of Economics and Finance and European Corporate Governance Institute and serves on the organization committees of the leading finance conferences. His research has been published by the leading finance and economics journals, including the *Journal of Finance*, *Journal of Financial Economics*, *Review of Financial Studies*, and the *American Economic Review*. He teaches courses in corporate finance and investment analysis at the undergraduate, graduate (MBA) and PhD levels and has won several teaching awards. Kenneth R French is the Roth Family Distinguished Professor of Finance at the Tuck School of Business, Dartmouth College. French is an expert on the behaviour of security prices and investment strategies. He and his frequent co-author Eugene F. Fama have written many notable papers, including *The Cross-Section of Expected Stock Returns*, *Common Risk Factors in the Returns on Stocks and Bonds*, and *A Five-Factor Asset Pricing Model*.

French is a research associate at the National Bureau of Economic Research, an Advisory Editor of the *Journal of Financial Economics*, the *Journal of Banking and Finance*, and the *Financial Review*, a member of the Editorial Board of the *Critical Finance Review*, a former Associate Editor of the *Journal of Finance* and the *Review of Financial Studies*, and a former President of the American Finance Association. Professor French is also a Fellow of the American Finance Association and the American Academy of Arts and Sciences, Chair of the Valpo Surf Project's Global Board of Directors, and a member of the Board of Directors of the Cato Institute, Grassroot Soccer, and the International Rescue Committee.

Professor French is a consultant to Dimensional Fund Advisors and a member of the firm's Board of Directors. He is also Co-chair the Dimensional's Investment Research Committee, and a regular speaker at Dimensional conferences and seminars.

Before joining Dartmouth, Professor French was on the faculty of MIT's Sloan School of Management, the Yale School of Management, and the University of Chicago Booth School of Business. Professor French received his PhD in Finance from the University of Rochester in 1983. He also earned an MS and an MBA from the University of Rochester and a BS from Lehigh University.

Suresh Sundaresan is the Chase Manhattan Bank Professor of Economics and Finance at Columbia University. He is the Faculty Director for the PhD programme in Finance and for the India Business Initiative (IBI) at the Columbia Business School.
